Sir,

I have the honour to forward herewith the Inspection report on the Shikshan Samiti High School, Nesari for the year 1955-56, and to state that the Shikshan Samiti High School, Nesari is recognised provisionally for the year 1955-56 ~~xx~~ for Std. VIII. teaching through the medium of Marathi and the provisional recognition so granted is continued for the year 1956-57 on condition that the suggestions made and defects pointed in several paras of the I.R. are carried out and remedied before the next inspection and also on the following conditions:-

1. The school should be kept open to all pupils irrespective of caste, creed and community and a certificate to that effect should be sent to this Office.
2. The provisions of Grant-in-aid code should be strictly followed.
3. The staff should be appointed on permanent basis as far as possible.
4. Furniture such as Dual desks, chairs, cupboards, tables and one black board should be purchased immediately.
5. Necessary equipment ~~xx~~ such as Science apparatus, books for libraries should be purchased. Physical Education apparatus should be provided.
6. Appointment of a trained graduate with 5 years' experience preferably a B.Sc. with D.P.Ed. should be made to work as a Head Master.
7. Appointments of a trained Science graduate, a D.T.C. and an H.S.S. should be made.
8. Govt. Provident fund scheme should be introduced with retrospective effect immediately and a general permission for opening the accounts in the post Office should be obtained from this Office.
9. Agreement bonds should be taken on Govt. stamped paper from all teachers.
10. Service books should be maintained in the prescribed form. Service ~~xx~~ conditions and leave rules should be ~~xx~~ framed and sent for approval.
11. All kinds of registers required for Library, Dead Stock, cash book, outward register, etc. should be maintained.
12. The accounts should be got audited after the close of the financial year, and copies of the audited statements should be furnished.
13. The Society should be got registered either under Societies Registration Act ~~xx~~ XXI of 1860 or under the B.P.T. Act of 1950.

14. The Society should maintain a reserve fund of atleast Rs. 3000/- at its credit.

15. A suitable building with adequate lighting and ventilation and accommodation should be secured.

A report about the ful-fillment of all the conditions should please be made before 31st March, 1956.
